For tax years ending December 31, 2014, and later, Form 1120-C filers that (a) are required to file Schedule M-3 (Form 1120) and have less than \$50 million total assets at the end of the tax year, or (b) are not required to file Schedule M-3 (Form 1120) and voluntarily file Schedule M-3 (Form 1120), must either complete Schedule M-3 (Form 1120) entirely or complete Form 1120-C, Schedule M-1, instead of completing Parts II and III of Schedule M-3 (Form 1120).

A corporation (other than a corporation that is a subchapter T cooperative) that engages in farming should use Form 1120 to report the income (loss) from such activities. Enter the income and deductions of the corporation according to the instructions for lines 1 through 10 and 12 through 29.

Enter on Form 1120-C the totals for each item of income, gain, loss, expense, or deduction, net of eliminating entries for intercompany transactions between cooperatives/ corporations within the consolidated group.
