It highlights the importance of understanding the cause of behaviour that challenges, and performing thorough assessments so that steps can be taken to help people change their behaviour and improve their quality of life.

Overview | Challenging behaviour and learning disabilities ...

A proportion of people with a learning disability will present behaviour that may be considered challenging. In adults this is around 10-15%. What we think of as challenging behaviours can vary, but this often includes aggression, self-injury and destructiveness.

Learning disability, mental health and challenging behaviour

Challenging behaviour is not a learning disability, but people with a disability are more likely to show challenging behaviour. This can be due to people having difficulty communicating and expressing frustrations. Challenging behaviour can also be a sign that something is wrong, like pain or discomfort, that your child cannot express in another way.

It may be difficult to determine if a child's learning disability is directly contributing to or triggering these types of behaviors. Family-related stressors can also have a significant effect on behavior at school.

How Learning Disabilities Can Affect Behavior

Learning disabilities and behaviour that challenges ...

Improving communication may be helpful in reducing or preventing challenging behaviour. People who have more severe learning disabilities are more likely to have more difficulties in communicating, and those people who have less communication skills seem more likely to have more frequent challenging behaviour.

Communication and Challenging Behaviour

The guideline can be read alongside NICE's challenging behaviour and learning disabilities; prevention and interventions guideline (NICE, 2015). The guideline focuses on a number of areas including: Managing risk and assuring quality of services. Involving people and their family members/carers.

This study explores the application of Weiner's cognitive-emotional model of helping behaviour to care staff responses to challenging behaviour of people with learning disabilities. Participants were 20 residential care staff who worked with people with challenging behaviour and 20 who did not.

Health and Challenging Behaviour
